**Annexation of Rosebud Schools**

Dinny Bennett reviewed the actions that have happened with in the past week in regards to Rosebud School Board of Trustees voting to place Rosebud School District k-12 in non-operational status at their May 8, 2017 regular board meeting. Dinny Bennett and Joby Parker, Rosebud County Superintendent of Schools had conversations in regard to the annexation of Rosebud Schools in to Forsyth Public Schools. Discussion followed on the request to have Forsyth School District pass a resolution to annex Rosebud Schools with or without the joint assumption of bonded indebtedness. Further discussion between Forsyth Schools Board of Trustees and, guests, Rosebud Schools Board of Trustees. Gerald Killen moved, to give Joby Parker, County Superintendent of Schools, the authority

to annex the Rosebud K-12 School District with the Forsyth Public School District. The annexation will be without the joint assumption of bonded indebtedness of the annexing district. It was seconded by Clay Redding. No further discussion. All trustees present voted in favor of the motion. Motion carried.
